VENDOR AGREEMENT

All vendors selling merchandise are required to hold a valid California Sellers Permit. There is no charge for the permit and can be obtained by calling the California State Board of Equalization at: 800-400-7115 or online at www.boe.ca.gov. If you sell less than twice a year or aren't selling anything, please complete the CDTFA-410 form instead through California State Board of Equalization.

This is a family friendly event. Items with bad language, inappropriate themes, political issues, or any toy weapons such as toy guns, etcetera are not allowed. No burning of incense or anything overwhelming. If any of these items are seen, you will be immediately closed down and must leave the event.

- 1. No generators are permitted, and no electricity is available.
- 2. Vendors are not allowed to distribute promotional flyers, etcetera outside of their space, use promotional barking or play loud music.
- 3. No beverage sales or beverage giveaways are allowed.
- 4. No free face painting.
- 5. No silly string is to be used or sold at this event.
- 6. No tobacco, cannabis or CBD products are allowed. (CBD may be sold with prior written approval by event management.)
- 7. No haybales/straw used for display.
- 8. Vehicles must be parked in designated area(s) one (1) hour prior to the event opening.
- 9. Only pre-approved items can be sold or given away from vendor spaces. There is an additional charge of \$35 for pre-packaged food vending.
- 10. Vendors providing services such as face painting, chiropractic, hands on services must provide a Certificate of Liability Insurance in the amount of \$1 Million dollars, naming the FUSION MUSIC FESTIVAL Event, Lodi Rotary, Lodi Kiwanis, and Lodi Lions as additional insured.
- 11. The Fusion Music Festival Event only provides the vendor space. Vendors must supply their own awnings and tiedowns/sandbags (in case of windy weather), tables, display boards, etcetera, and must stay within their allotted space.
- 12. Vendor products are not allowed to be leaning on buildings or trees.
- 13. Vendors will receive a vendor packet that will have instructions for the event, a map that will indicate your business name, location and booth size, and directions as to the entrance and parking of vehicles.
- 14. Vendors are not promised exclusivity. Event management reserves the right to refuse service to anyone.
- 15. Should you have any issues during the event, contact the event information desk.
- 16. In case of inclement weather, the Fusion Music Festival Event will go as planned. The Fusion Music Festival Event is unable to have rain dates or give refunds or credits.
- 17. There will be NO REFUNDS after Sunday, September 1, 2024. A \$35 processing fee will be added to all refunds issued before this date.
- 18. An additional \$50 charge will be added to any returned checks.
- 19. NO AMIMALS WILL BE ALLOWED.
