APPLICATION INSTRUCTIONS

- All fields are mandatory. To avoid delays, please double-check each field before submitting your application.
- Admittance into the FUSION Event is at the sole discretion of the FUSION Event Management. If not accepted into the event, payment will be refunded in full.
- Payment must be made in full on or before Friday, April 14, 2023
- There will be NO refunds for dissatisfaction of sales or booth location, change of mind, no-show, or inclement weather.
- Vendors must abide by the FUSION Event rules and regulations as well as those of the Lodi Police and Fire Departments, State Board of Equalization and San Joaquin County Environmental Health Department.

VENDOR RESPONSIBILITY

- Reading, understanding, and following all FUSION Event Rules and Regulations.
- Assembling and staffing your own booth/truck.
- Purchasing/supplying all food, materials, and equipment necessary to properly and safely run the booth/truck.
- Comply with all Police and Fire Department Rules and Regulations (Fire Department: 209-333-6735).
- Collection and handling of money for your own business.
- Booth display signage.
- Adhering to San Joaquin County Environmental Health Department Rules and Regulations.
- Cleaning your area after the event. Leaving no trash. Space **MUST** be left as found.
- No selling outside of your space is allowed.
- Complete and sign the mandatory Liability Clause below. Return original signed copy with Application. Keep a copy of all paperwork for your records.
- You may not serve beverages or additional food other than what is listed and approved.
- Food vendors must provide a copy of their certificate of liability in the amount of \$1/\$2 million naming the FUSION Event as additional insured.

- Liability Insurance must be enclosed with this Application.
- San Joaquin County Temporary Food Vendor's Application.
- A copy of a valid seller's permit.
- Payment in full with Application.
